

## The Leaderboard Competition

### Official Rules

#### NO PURCHASE NECESSARY TO ENTER OR WIN

**The Leaderboard Competition (the “Contest”) starts at 12:00AM Pacific Standard Time (“PST”) on March 1, 2026 and ends at 11:59PM PST on March 31, 2026 (“Contest Period”).**

Your participation is subject to (i) Fansly’s Terms of Service (<https://fansly.com/tos>); (ii) Fansly’s Privacy Policy (<https://fansly.com/privacy>); and (iii) any other terms, conditions, and rules published or made available by Fansly as such terms may be amended from time to time (the “Platform Documents”). To the extent there is any conflict or inconsistency between the provisions of these Official Rules and the provisions of the Platform Documents, the provisions of these Official Rules shall control. Terms not defined herein shall have the meanings ascribed to them in the Platform Documents.

**ELIGIBILITY:** The Contest is open to individuals who are 18 years of age or older and have a Fansly Creator account as of the start time of the Contest. Void where prohibited by law. The Contest is subject to all applicable laws. By participating, each entrant agrees to abide by these Official Rules and decisions of Fansly, which shall be final and binding in all respects relating to this Contest.

**HOW TO ENTER:** During the Contest Period, to enter, visit [fansly.com/leaderboard](https://fansly.com/leaderboard) and click “opt-in” to join for the Contest before March 31, 2026 at 11:59PM PST.

#### **CONDITIONS OF ENTRY:**

Upon opting-in to the Contest, you will have your profile shown on the public Fansly leaderboard. If you wish to be removed from the public leaderboard, you can, at any time, opt-out of the Contest at [fansly.com/leaderboard](https://fansly.com/leaderboard). If you are not opted-in to the Contest at the time the Contest closes, you are not eligible for any reward. For example, if you opt-in to the Contest at 12:00AM PST on March 1, 2026, and you opt-out of the Contest at 11:58PM PST on March 31, 2026, you will **not** be eligible for any rewards.

**WINNER DETERMINATION:** The top 500 entrants on the leaderboard as of the conclusion of the Contest Period will be deemed potential winners of the Contest. The leaderboard tracks total aggregate revenue of an entrant during the Contest Period. **Only the leaderboard positions at the close of the Contest Period matter. In other words, someone who is #1 for the entire Contest Period, but falls to #2 upon close of the Contest Period, will be considered #2 for the purposes of determining rewards.** In the event of a tie for any prize level, the winner will be determined by whomever registered first. Fansly reserves the right to not award all prizes if, in

its sole discretion, it does not receive a sufficient number of qualified entrants. Fansly's decisions are final and binding.

**LEADERBOARDS:** The leaderboard may not be accurate or in real-time. Sponsor reserves the right to alter the leaderboard due to technical issues or if there has been unsportsmanlike or other behavior prohibited by these Official Rules. Winners are responsible for all federal, state and local taxes. All winners will also receive a frame or banner around their profile indicating that they are winners of the Contest. The frame/banner has no cash value and cannot be transferred or substituted, except by Fansly. All prize awards are subject to verification of eligibility and compliance with these Official Rules.

**WINNER NOTIFICATION:** Potential winners will be notified by in-app message or email on or after April 8, 2026, and may be required to execute and return an Affidavit (or Declaration) of Eligibility, Publicity Release, and a W-9 form within the time period stated therein.
